Annual Progress Report, 2021

Sangamon County Multi-Jurisdictional Natural Hazard Mitigation Plan: 2015 Update

Background

In 2017, Sangamon County and various municipalities in Sangamon County adopted the *Sangamon County Multi-Jurisdictional Natural Hazard Mitigation Plan: 2015 Update* per FEMA rules. FEMA regulations for hazard mitigation plans require at least an annual meeting of a workgroup to a) promote accountability for the Plan to various community governing boards; and to b) keep the hazard mitigation plan alive, so its recommendations do not become outdated.

The Workgroup appointed to maintain the 2015 Plan consisted of representatives of each participating community and two organizations as follows: Auburn, Buffalo, Cantrall, Chatham, Divernon, Jerome, Leland Grove, Mechanicsburg, New Berlin, Pawnee, Rochester, Sherman, Southern View, Springfield, Williamsville, Sangamon County, the Springfield Homebuilders Association, and the Sangamon County Office of Emergency Management. The Plan states: "The Workgroup will meet at least twice a year to review the progress of the communities in implementing the Plan and to prepare a progress report to be submitted to the governing bodies of all communities. The report will include an evaluation of the Plan and identify any areas that may need to be revisited." (p. 105). The Plan further indicates that the reporting period begins on "the date that the first community adopts the final Plan" (p. 105). The Workgroup met twice in 2021 as detailed below. This is the second progress report, and it corresponds to a reporting period of January through December 2021. The first progress report was last year and covered the period 2017-2020.

Workgroup Members received the list of their community's Action Items (as modified at last year's annual meeting) to prepare for the 2021 annual meeting. Participants were asked to assess each Action Item's status and return the information to staff approximately one week after the meeting. A more detailed assessment of the status of Actions Items is on the **attached** Action Items table.

Public Meetings

The Workgroup met twice in 2021 as specified in the Plan. The first meeting occurred on July 7, 2021. The Workgroup discussed strategies to meet action items, weather events, and BRIC funding, as indicated in the **attached** minutes. The Workgroup also met for the annual meeting on December 7, 2021. Due to COVID-19 and staffing issues, both public meetings occurred via Zoom. There were eleven in attendance representing ten participating communities and one non-governmental organization, the Springfield Homebuilders Association. The **attached** minutes indicate meeting attendees, including one representative from Sangamon County.

Assessment of Existing Action Items from the Plan

As homework for the public meeting, a listing of Action Items was sent to each Workgroup member. A listing of the Workgroup and the taxing body replies to this request is **attached**. If a community did not participate in the 2015 Plan, was unable to attend the Workgroup meeting, or able to submit the homework, their Action Items are marked as Unknown. As the only CRS representative in the group, Sangamon County participated in the meeting and updated its Action Items included in the Plan. Sangamon County's updated status on each of its Action Items is either in the Status column if

unchanged from the Hazard Mitigation Plan or in the far right column for items that have been updated since the Plan was implemented. Cantrall's representative did not attend the meeting due to work requirements. However, he did complete an assessment of Cantrall's Action Items, including a status update on each item. Cantrall indicated it might seek grant funding to help with a drainage project for stormwater coming from a school in the community. Buffalo's representative did not make the meeting but did turn in an assessment of the community's action items. Revisions to the Status column in red represent changes made by certain communities since the Plan.

Assessment of New Project/Action Items or Revised Recommendations for the Plan

There were no revised recommendations (goals or objectives) to report. Many Workgroup members did not have new projects/Action Items for the Plan based on experiences from 2021. New projects for 2021 by the Villages of Buffalo, Rochester, and Southern View and Sangamon County are red on the **attached** table. Other projects are in red that were new projects from last year's annual report. The Hazard Mitigation Task Force intended that the Action Items table below would be a living, breathing document updated with new projects, if applicable. The rest of the Hazard Mitigation Plan was only to be changed once every five years when a new plan Task Force is convened.

Why Some Action Items Have Not Been Completed

In general, two factors were cited as to why communities did not complete projects. First, projects were delayed because communities lacked funding, including grant awards. Second, there has been some significant staff turnover and general staffing issues in several participating communities. New staff are often unaware of the Hazard Mitigation Planning process and the responsibilities of participating organizations.

Assessment of New Weather Experiences Based on the Previous Year

Most communities reported no significant new weather challenges at the December 7, 2021 meeting. The most prevalent challenges appeared to be high wind events, flooding, and severe storms. Sherman, Jerome, and Chatham reported some damage to equipment and streets due to severe storm events.

How the Plan Was or Will Be Made Available to the Governing Boards, the Public, and the Media

The report was distributed to the Sangamon County Board members at its regular monthly meeting in January 2022. The report was also emailed to other Workgroup communities and the two taxing bodies mentioned above with a request to show the report to the community's governing board at a regular upcoming meeting in January 2022. The report was made available to the public in January 2022 through posting to the SSCRPC's website and Facebook pages. A link to the report on the SSCRPC's website was also emailed to the Workgroup members and the two taxing bodies' representatives. The report will be released to the media in January 2022.

- Call to order Nate Bottom called the meeting to order at 3:00 PM. After introductions, he turned the floor over to Steve Keenan, Springfield-Sangamon County Regional Planning Commission (SSCRPC).
- 2. Community Reports Keenan shared a brief presentation about why FEMA requires meetings for this body. Keenan then introduced the community reports. He explained the plan called for the Work Group to meet twice per year, emphasizing that the plan indicated a yearly progress report be submitted to all the governing bodies of all (participating) communities.

The following communities and an organization gave reports.

<u>Williamsville</u> – John Brennan stated that an unstable siren was detected during the yearly maintenance check on sirens. The siren is still operational, but it needs to be replaced. The replacement unit has been ordered and will be installed in the next six weeks.

Brennan stated that critical infrastructure updates to the sewer system are beginning. Sand filters and aerators will be replaced, and monitoring equipment and pumps will be installed. This will allow for closer monitoring of the sewer system and help to avoid system instability and/or failure. They will probably be voting on letting the bid next week.

<u>Chatham</u> – Trent Thompson stated that projects have not moved forward because they are waiting on funding that was delayed due to COVID-19.

They have a communications plan procurement that they anticipate will be executed in the next quarter.

Thompson stated that recent storms (June 27) caused some damage. The computer system for the water distribution system failed leading to a 24 hour boil order. The repeater for the Emergency Management and the Police Department was damaged. A transformer was damaged which caused some power outages. They are working to repair these issues. They have two malfunctioning sirens that may have been hit by lightning. They are waiting for the results of a recent inspection to determine the next steps.

<u>Sherman</u> – Mike Moos stated that current projects are on hold due to receiving less funding from the State of Illinois than anticipated. They have received some federal funding but not enough. They are waiting for more funding notifications to be released through the natural mitigation planning process.

Keenan stated that there were several million dollars in grants applied for under the Building Resilient Infrastructure and Communities (BRIC) program, but the State of Illinois only received about \$600,000. He urged communities to check IEMA's website in August for further Notice of Funding Opportunities.

Moos wondered if a "combined regional effort" would be beneficial. Keenan suggested reaching out to the Regional Leadership Council (RLC) for assistance. Moos stated that he heard about a universal connection system for generators and wonders if this could help some of the smaller communities obtain generators.

<u>Southern View</u> – Lisa Cave stated that the first three items on their list have been completed. The main building does not have a generator, but it should since it is designated a "safe place." They are unable to purchase one at the current time due to funding delays caused by COVID-19.

Cave stated that they are battling drainage issues and improving drainage ditches. There was no significant damage from the recent storms.

Sangamon County OEM – Chris Dodd stated that he has no updates at this time.

<u>New Berlin</u> – Terry Nydegger stated that the recent storms caused very little damage. He had no further updates.

<u>Auburn</u> – John Edie stated that they completed phase one of their water main project which will help alleviate future breaks and service disruptions. There are plans for a second feed to be completed by the end of the year so that they can receive water from two points.

They had some minor flooding due to recent storms but little to no damage. They have been approved to start engineering on a new lift station on the west side of town to help with flows.

<u>Springfield</u> – Nate Bottom stated there was some localized flooding due to recent storms. The City is clearing downed branches from subdivision main streets. Work is being done to reset or reprogram some traffic signals that were hit by lightning. Work is being done on an intergovernmental agreement with the Sangamon County Water Reclamation District to try and relocate some of the pump stations in the northeast area that includes the administrative border for sanitary sewer overflow.

The environmental stage and phase one design on MacArthur Boulevard is starting to upsize and relocate some storm sewers. Additional compensatory storage is being added near Koke Mill and Washington Street to help with major flooding. Larger pumps and additional detention will be added later this month for Cook Street and South Grand Avenue as part of the Rail Improvements Project area. A washout on Sandhill Road caused by the June 27th storms prompted emergency repairs near the Sangamon County landfill, which are complete.

<u>Pawnee</u> – Dave Skinner referenced a project update for Pawnee sent prior to the meeting (which is attached). He stated that engineering is complete on a water main needing repair between Auburn and Pawnee. Permit applications have been submitted and are awaiting approval. Engineering began for a storm sewer project that will probably start in 2022. A new generator was purchased for the police station. Skinner wondered if they have access to funding from President Biden's infrastructure plan. Keenan suggested contacting RLC or federal legislators to answer those questions.

- 3. Discussion of Future Tasks There was no discussion of future tasks.
- 4. Public Comment There was no public comment.
- 5. Adjournment Trent Thompson made a motion, seconded by Lisa Cave, to adjourn. Motion carried unanimously. The meeting adjourned at 3:27 PM.

- Call to Order Steve Keenan, Springfield-Sangamon County Regional Planning Commission (SSCRPC) requested a motion to approve the minutes of the July 7, 2021, meeting of the Sangamon County Multi-jurisdictional Natural Hazards Mitigation Plan Update Task Force. Chris Dodd moved to approve the minutes as submitted. Steve Sturm seconded the motion, and the motion passed unanimously via voice vote.
- 2. Community Reports Keenan shared a brief presentation on FEMA meeting requirements for this body. Keenan then introduced the community reports. He explained that the plan called for the Work Group to meet twice per year, emphasizing that the plan requires a yearly progress report to be submitted to all the governing bodies of all (participating) communities toward the end of the year. A new multi-jurisdiction hazard mitigation plan is slated to begin work in 2022.

Keenan noted that it is very important to give thought to the 2021 annual report because of the new upcoming plan and to provide accountability to FEMA (Federal Emergency Management Agency). Keenan stated that communities do not have to report on new list items this year, but it is something to think about in the future. He also mentioned that the plan does not guarantee funding, but it allows communities to have the opportunity to apply for hazard mitigation grant funds in the future.

The following communities and organizations gave reports.

<u>Chatham</u> – Trent Thompson stated that the Village of Chatham began making improvements in the procurement of communications equipment that resulted in more streamlined audio/visual and computer capabilities for multi-organizational responses to hazardous events. They have acquired approximately 10% of the necessary funds. He noted that delays in state funding are the most significant barriers they have encountered. Thompson stated that the village is still in the process of burying its electrical grid, especially the lines that serve critical facilities. He mentioned that the Village of Chatham has not identified any new projects to add to their homework sheet. He said they would continue to work on the projects that are currently listed. Thompson noted that there have been no major negative impacts from weather events in 2021.

<u>Divernon</u> – Chuck Apgar stated that the Village of Divernon resurrected its print newsletter quarterly, and after some technical difficulty, they began sending notifications to residents via the CivicPlus E-alert system — text, phone call, and email through the village office. He mentioned that the only barrier they are facing is getting people to read the newsletter and opt in to the alerts. Apgar stated that there is good communication between property owners within the floodplain and the Public Works Department regarding flood plain regulatory requirements. He also noted that the temperature drop in February caused higher than average gas prices but other than that, Divernon has had no major effects from weather.

<u>Jerome</u> – Dale Lael stated that the Village of Jerome is still working on purchasing a generator for the municipal complex. They have received some bids, but they are waiting on funding. Lael mentioned that all of the culverts were jetted this year, and the street department adjusted the ditches that significantly improved water flow. Lael stated that the village has noticed several unhealthy trees. They have identified three trees for removal.

<u>Leland Grove</u> – Tyler Lanier stated that the City of Leland Grove has started a drainage committee comprised of board members and non-board members. The committee is tasked with identifying new drainage issues. Lanier noted that clogged culverts were jetted this year, and residents were given notice via the Leland Link newsletter that they cannot discharge sump pumps onto the sidewalk or into the road, and they are required to keep their ditches free from debris. He mentioned that Leland Grove plans to contact an engineer to create a map of the current city drainage system to assess where new drainage needs to be added. Lanier mentioned that a few trees had fallen into the creek this year and debris had accumulated near the bridges which required removal. Lanier stated that the City suffered no major weather-related effects in 2021 and that the current items on the homework sheet should remain the same going forward.

<u>Pawnee</u> – Dave Skinner stated that the Village of Pawnee has begun engineering to switch from 6 inch to 10 inch water mains around the square, which should alleviate issues in the event of a fire. He mentioned that the new 16 inch water line extending from BAB Road in Auburn to Pawnee is currently being engineered with some progress anticipated in 2022. Skinner noted that the village would like to construct a storm shelter and eventually a new school, but grants are necessary for funding. Skinner stated that the village suffered no major weather-related effects in 2021.

Rochester – James Foster stated that the storm sewer project, which consisted of replacing a 10 inch drain with a 24 inch drain on North Walnut Street, has been completed allowing water to drain much quicker. Foster noted that he still anticipates the implementation of flood protection on one of the south lift stations that sits very close to the river. He mentioned that the Village continues to line manholes to stop infiltration, and when that project is complete, they plan to proceed with work on the laterals. He stated that the purchase of a generator for Public Works has been put on hold for several reasons. Foster stated that the village has annexed some new land to one of their parks that was previously private property. The Black Branch runs through the newly acquired property, and there are trees and debris that require cleanup. Foster mentioned that Rochester attempted to join the SAM (Sangamon Area Messaging System), but ran into some logistical issues. He mentioned that the weather caused some flooding and strong winds this year, but there was no major damage.

<u>Sherman</u> – Mike Moos stated that the Village of Sherman is working with an engineer and the Public Works Department to address the problems on the homework sheet. Most of the items on their sheet are still relevant issues, but they are concerned about securing funding to complete those projects. Moos noted that straight-line winds caused tree damage, and storms created some flooding, but they avoided tornadoes. Moos thanked the other communities that reached out to help.

Springfield – Nate Bottom stated that this year the City of Springfield experienced high winds which caused some power outages and downed branches, but no major damage was sustained. Bottom noted that work continues on jetting sewers and grading and inspecting major outfall structures. Flood markers were reinstalled on Koke Mill Road. Bottom mentioned that the City is currently working on a hydraulic report that is part of the Koke Mill Road widening project. He noted that ditch work and culvert installation was done near Lincolnshire subdivision to alleviate flooding by Chatham Road. He also stated that a new pump station was completed on Laurel Street to alleviate flooding in that area. Bottom noted that there have been some snow route modifications as well as some upgrades to snow removal equipment.

<u>Williamsville</u> – John Brennen stated that the sewer plant renovations are moving forward despite some cold weather. Brennen noted that 3 or 4 days of steady rain caused sewer issues, and it was discovered that several residents were draining their sump pumps into the village's storm drains. Residents are being notified that they are prohibited from doing this and provided information on the correct procedure for sump pumps drainage. He mentioned that they sustained some damage from straight-line winds, but the tornadoes bypassed them. Brennen stated next year the village will perform a floodplain assessment near the creek. They will proceed as needed once they receive the engineer's report.

<u>Springfield Home Builders Association</u> – Steve Sturm stated that the Sangamon County Board has adopted the 2018 International Building Code and the 2017 National Electrical Code. These codes take effect on January 1, 2022. Sturm noted that ideally, the other communities in Sangamon County will follow suit and adopt these codes.

<u>Sangamon County (Office of Emergency Management)</u> – Chris Dodd stated that straight-line winds and excessive rain caused minor issues, but the area was bypassed by tornadoes. Dodd noted that everything on their homework sheet should remain the same.

- 3. Discussion of Future Tasks Keenan briefly reviewed the homework and annual report tasks to be completed in the next few weeks.
- 4. Public Comment There was no public comment.
- 5. Adjournment Chris Dodd made a motion, seconded by Trent Thompson, to adjourn. Motion carried unanimously. The meeting adjourned at 3:35 PM.
