**AN ORDINANCE ESTABLISHING SALARIES FOR
CERTAIN VILLAGE EMPLOYEES**

WHEREAS, the Village of Sherman ("Village") is a home rule municipality pursuant to Article VII, Section 6 of the constitution of the State of Illinois; and

WHEREAS, as part of its budget and planning process, and the adoption of same, the Village sets forth a salary schedule for its employees; and

WHEREAS, the corporate authorities of the Village desire to establish the salary schedule for Certain Village Employee as set forth in this Ordinance.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Sherman, Illinois, as follows:

Section 1. Recitals. The foregoing recitals shall be and are hereby incorporated into and made a part of this Ordinance as if fully set forth in this Section 1.

Section 2. Salary Schedule. The salary schedule set forth in the attached Exhibit A shall be effective for the employees identified therein and shall be effective as of the dates listed.

Section 3. Repeal. All Ordinances or parts of Ordinances in with this Ordinance are hereby repealed insofar as they are in conflict with this Ordinance.

Section 4. Severability. If any provision of this Ordinance or its application to any person or under any circumstances is adjudged invalid, such adjudication shall not affect the validity of the Ordinance as a whole or of any portion not adjudged invalid.

Section 5. Effective Date. This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law where indicated on the Attached Exhibit A.
